1. DATE & PLACE	:	26 th to 27 th Dec'2015, - Khudiram Anusilan Kendra, Eden Gardens, Kolkata –700001. Reporting by 4 p.m. on 25 th Dec'2015
2. PROMOTER/ORGANIZER	:	BENGAL AMATEUR TAEKWONDO ASSOCIATION
3. DIVISIONS	:	Senior, Junior. Sub-Junior & poomsae

5. QUALIFICATION	:	For Sub-Junior – Below 14 years. For Junior – Below 17 years. For Senior – Above 17 years
6. SPOT REGISTRATION	:	Spot Registration will not be entertained Fooding & Lodging :- 25.12.2015 Dinner to 27.12.2015 Dinner
7. COMPETITION RULES	:	World Taekwondo Federation Competition Rules. Single Elimination Tournament System. All participants must be in possession of their B.A.T.A I.card.

8. ENTRY FEE	:	Rs.700/- for Each Player FOR Kyorugi (SPARRING) AND RS.700/- PER PLAYER FOR POOMSAE. RS.1200/- FOR COMBINED ENTRY. (1EACH PLAYER WILL BE GIVEN ONE UNIFORM EVEN IF HE/SHE PARTICIPATES FOR COMBINED ENTRY) The last date for receipt of <u>original Entry Forms along with Entry fee is 10th December'2015</u> positively. No Applications will be entertained after the last date. Entry Fees is to be paid along with Refundable Security Deposit Rs.1000/- each team. <i><u>Due receipts will be provided and the same will be returned from the office at a later date, if no damage is done by them nor any sort of nuisance created or any kind of indiscipline done. The security deposit can also be impounded if false documentation or weight category is given. Improperly filled up forms also will attract the same penalty.</u></i> <i><u>The Committee's decision to refund or not refund shall be considered final in case of any anomaly.</u></i>
9. TEAM ENTRIES	:	Manager - 01 INCLUSIVE OF POOMSAE Coach - 02 INCLUSIVE OF POOMSAE Contestants - Individual Entry <u>Forms to be filled in totality with correct weight.</u> <u>Strict action shall be taken against both players and their coaches for indulging in Age Fraud</u>
10. PROTECTIVE EQUIPMENTS	:	Organizers to provide Chest & Head Guards only. Contestants should wear their own Dobak, Groin Guard, Forearm Guard, Shin Guard and Gum shield Compulsarily.
11.APPOINTMENT OF REFEREES	:	The required number of Referees will be appointed by B.A.T.A. If required, these Referees will be provided Boarding and Lodging during the Championships.
12. CONDITIONS OF PARTICIPATION	:	(a) <u>Wrong weight categories will be disqualified on spot.</u> <u>NO EXTRA PERSONS ARE ALLOWED TO STAY.</u> (b) Drawing of Lots shall be done on 25 th December from 5 p.m. to 6 p.m. at the Venue:- District representatives should be present for Drawing of Lots. Absentees will be substituted by B.A.T.A. Officials. (c) <u>It is the responsibility of the Participant and District/Unit to submit the Player's</u>

		<u>the Spot also. Those having given wrong weights or wrong Age will not only be disqualified, their Refundable security money will be confiscated. Original Age Certificate should be produced at the time of Weigh-in .</u>
13. INDEMNITIES	:	It shall be responsibility of the respective Districts/Clubs/Units to ensure that their contestants have validly completed the participation forms and have them signed by the Parents/ Guardian and contestants indemnifying the Organizers, the Officials and other Contestants from any claims of injuries, losses, fatal or otherwise arising in the course of participation in this Championship or any activities thereto.

15. MEDICAL CONTROL	:	(A) Use of Drugs or Doping by any Chemical substances prescribed in the WTF Regulations for Doping Control is strongly Prohibited. <u>Not giving the correct Age would be taken as Age Fraud.</u>
16. PROTEST IF ANY	:	In case, there is Objection towards a Judgment, Age or Weight, the concerned Coach / Manager must submit the Protest Application Form together with Prescribed Fee of Rs.1000.00 (Non-Refundable) to the Board of Arbitration within ten minutes after the pertinent contest. Deliberation will be done as per WTF Rules by the Arbitration Committee and their verdict shall be considered final and valid.

N.B.I OUTSTATION ATHLETES, WHO WILL BE USING THE ACCOMMODATION KINDLY BRING YOUR OWN BEDSHEETS AND PILLOWS SINCE THE SAME WILL NOT BE PROVIDED. IT IS ADVISABLE TO ALSO CARRY A TORCH, AN UMBRELLA, BIRTH CERTIFICATION, OWN MEDICINES, WATER BOTTLES AND NECESSARY TAEKWONDO EQUIPMENT
